Suggestions to Help

Example

CELI CTIVITY SOCATION **MS** RESPONSE *IME* USPECT

What do you see? Crime? Suspicious activity? Where is it? Address is best! Emergency Medical Service needed? (Ambulance) When did this occur? In progress? A few minutes ago? Describe people & vehicles. Armed? Present location, or where you saw them go. Answer questions as clearly as possible! OPTIONAL THINGS YOU CAN DO TO HELP:



Identify yourself by name when you call. Stay on the phone if asked. Call 911 with updates if situation changes. Wait for police to arrive. Help if asked!

EXAMPLE: "Shooting at 54 2d Ave., one person wounded in the arm 3 minutes ago. Suspect is a 5'10" male with brown hair & yellow shirt. Armed with a revolver moving north on Fry!"



Report Format

CTIVITY LOCATION 3MS RESPONSE **LIME**

USPECT

What do you see? Crime? Suspicious activity? Where is it? Address is best! Emergency Medical Service needed? (Ambulance)

When did this occur? In progress? A few minutes ago?

Describe people & vehicles. Armed? Present location, or where you saw them go.



The suspect was driving an older 2-door Oldsmobile with a black body. The car had a orange and white license plate, CXR 555.

-DESCRIBING A PERSON-CLOTHING

Hat, Coat, Shirt, Pants, Socks, Shoes, Accessories, Jewelry, Grooming, Oddities

PERSONAL

Sex, Race, Age, Height, Weight, Build, Gait

FACIAL

Hair, Forehead, Eyes, Nose, Cheeks, Ears, Mouth, Chin, Neck, Complexion, Facial Hair, Tattoos VOICE

Pitch, Tone, Lisp, Rasp, Accent, Slang, Educati

The subject was wearing a light blue shirt, faded blue levis, and black running shoes. White male in twenties, about 5' 6" and 150 pounds, with short brown hair. Armed with large caliber revolver!

What is happening

Where did it happen? Address best, street intersection OK, "400 yards west of Walmart" if you have to.

Injuries that require immediate response by Emergency Medical Services

When did this occur? In progress? A few minutes ago? Hours ago? This determines the urgency of getting police or medical to the scene.

Description (person or vehicle), **Armed? With what? Location now** or where you saw him go

suspect is 5'4" female, about 23 and 130 pounds, with long braided brown hair, yellow shirt, and blue jeans. Walking south, unarmed."
